FTR Log Notes presents a familiar interface that mimics existing paper-based log sheets. Users can thus effortlessly transition to an electronic note-taking tool and enjoy the many conveniences offered, such as quick search and retrieval of notes related to particular cases and immediate access to recorded content through hyperlinked timestamps.
